

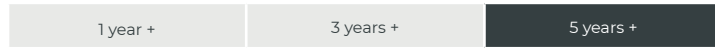

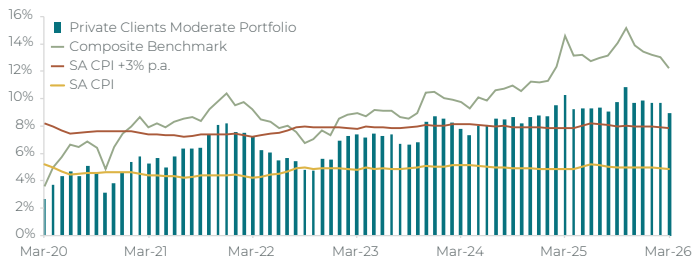

5-YEAR ROLLING RETURNS

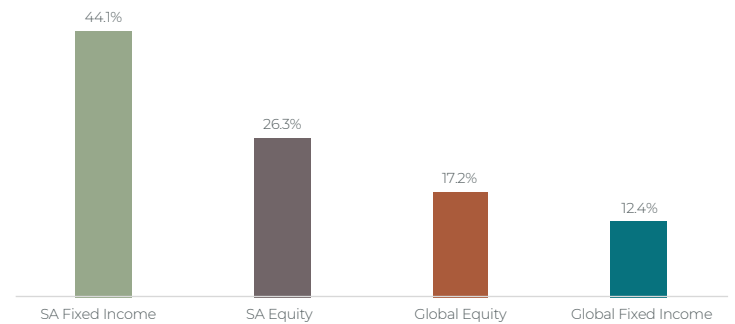
