

CASH4♥ONES BENEFIT

In many cases, whole families rely on the monthly income benefit a person receives after they become disabled. When a disability claimant dies, it can cause financial stress for many dependants. To help your loved ones through this difficult time, Old Mutual Group Assurance Products offers the dependants of a claimant the Cash4♥Ones benefit. Disability claimants already in receipt of an income protection benefit have the opportunity to nominate a beneficiary to receive a small cash lump sum should they die.

WHAT YOU NEED TO KNOW:

- Complete the Cash4♥Ones Nomination Form when you submit your income protection claim. This form is section 2 of the application pack and can be found on the website.
- The beneficiary that you nominate to receive this benefit must be older than 18 years and have a valid bank account. We require a certified copy of the nominated beneficiary's identity document with the completed Cash4♥Ones Nomination Form.
- Your nominated beneficiary may be eligible to receive the Cash4♥Ones benefit if your disability benefit is approved, you have submitted a complete Nomination Form, and your beneficiary is over the age of 18 with a valid bank account.
Note: payment of the benefit is always subject to the terms and conditions in the policy document.
- If a Cash4♥Ones Nomination Form was not completed and submitted to us before your death, the benefit, if approved, will be paid to your bank account (your estate).
